

STATE LEVEL COORDINATION & INTEGRATION PLAN - Objectives and Activities for meeting GOAL 2 for Project AWARE

Goal 2: Project AWARE Ohio will guide and support local communities in implementing effective mental health services that are:

1. determined by data-driven needs;
2. provide a multi-tiered system of support; and
3. are culturally and linguistically appropriate to Ohio's youth.

Needs and Gaps: Based on the Safe Schools/Healthy Students Needs Assessment and SMT discussions, local entities may not be using data to effectively identify programmatic needs. They may not have support to identify and implement quality and effective school-based BH practices. Schools may not have model programs to emulate.

Across the state there is a lack of data available at the state and community levels regarding behavioral health in schools, school mental health, or school initiatives. The 2014 OhioMHAS Behavioral Health Priorities Survey showed that 48% of respondents suggested that education the community about mental illness and substance abuse was the highest prevention priority for the state of Ohio's behavioral health system of services. Other prevention areas that respondents suggested be considered for priority funding included: Stigma Reduction Campaigns ($n = 129$, 66%), Early Identification and Education ($n = 126$, 4%) and suicide prevention ($n = 1$, 4%).

There is no oversight of BH providers hired by schools at the ODE level (e.g., there is no identified office to provide support to school social workers and counselors). There is lack of state level guidance for school protocol. In addition, Ohio recently rescinded the 5 of 8 Rule which required schools to have at least five of eight identified positions which included counselors and social workers. The Children's Defense Fund-Ohio notes that 47% of Ohio's families are identified as economically disadvantaged (and thus high-need families) and many youth experience behavioral health problems that impact their academic and social-emotional functioning.
